

JACK - "Guardians of the Galaxy - Mission: BREAKOUT! Alaska Airlines Giveaway"  
CONTEST RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE ENTRANT'S CHANCE OF WINNING.**

1. HOW TO ENTER

- a. These rules govern the JACK Guardians of the Galaxy - Mission: BREAKOUT, Alaska Airlines Giveaway promotion (the "Promotion"), which is being conducted by KJAQ-FM (the "Station"). The Promotion begins on Monday, June 26, 2017 and ends on Friday, July 7, 2017 (the "Promotion Dates").
- b. To participate in this Promotion, entrant may enter via text message or online beginning on Monday, June 26, 2017 at 6:00am Pacific Time ("PT") and ending on Wednesday, July 5, 2017 at 8:00am PT, (the "Entry Period") as follows:
- c. Entrants must listen to the Station:
  - i. Beginning on Monday, June 26, 2017 and ending on Friday, June 30, 2017 and beginning on Monday, July 3 and ending on July 4 at the following approximate times for the unique keyword announcement (the "Keyword") and cue to enter: 7:00am PT, 8:00am PT, 9:00am PT, 10:00am PT, 11:00am PT, 12:00pm PT, 1:00pm PT, 2:00pm PT, 3:00pm PT, 4:00pm PT, 5:00pm PT, 6:00pm PT, and 7:00pm PT.
  - ii. Beginning on Saturday, July 1, 2017 at 7:00am and ending on Sunday, July 2, 2017 at 11:59pm for the Keyword announcement and cue to enter.
  - iii. Wednesday, July 5, 2017 at the approximate times for the Keyword and cue to enter: 7:00am PT and 8:00am PT.

Once you hear the Keyword, enter either via text message or online as follows:

- I. **Text Method**: Text the Keyword announced on air to 96750 to enter the Keyword for the specific hour and day to enter the Promotion during the Entry Period. Message and data rates may apply. The Station is not responsible for any fees incurred by an entrant for this method of entry. Potential prize winner(s) in a text message promotion must provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth to verify eligibility. P.O. Boxes are not permitted. By entering by text, entrants consent to receive a confirmation text message from the Station.

OR

- II. **Online Method**: To enter online, visit [jackseattle.com](http://jackseattle.com) and follow the links and instructions to enter the Promotion and complete and submit the online entry

form during the Entry Period. Each entry must include the Keyword for the specific hour and day. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. P.O. Boxes are not permitted. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Promotion administrator.

Entries with Keywords announced 7:00am PT, 8:00am PT, 9:00am PT, 10:00am PT, 11:00am PT, 12:00pm PT, 1:00pm PT, 2:00pm PT, 3:00pm PT, 4:00pm PT, 5:00pm PT, 6:00pm PT, and 7:00pm PT will be valid until the announcement of the next Keyword (e.g. entries with the Keyword announced at 7:00am PT will be valid until the next Keyword is announced at approximately 8:00am PT). Entries with Keywords announced at 7:00pm PT will be valid until 11:59pm PT that day.

- d. Limit one (1) entry per person per Keyword, regardless of method of entry. Multiple participants are not permitted to share the same phone number or email address. There will be up to a total of twenty (20) Qualifying Prizes winners and one (1) Grand Prize winner selected in the Promotion.
- e. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests. Entrants are encouraged to listen to the Station on-air. The Station is not responsible for online streaming delays.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are legal U.S. residents 18 years of age or older and who reside in the greater Seattle Metropolitan area (Island, King, Kitsap, Pierce, Snohomish, and Thurston Counties, Washington). Void where prohibited or restricted by law. Employees, officers, directors and agents of Disney Destinations LLC, the Station, CBS Radio Inc., their corporate affiliates, Station's advertising and promotional agencies, participating sponsors, prize suppliers, their respective affiliates (collectively, the "Promotion Entities") and other radio stations in the Greater Seattle metropolitan area, the members of their immediate families (spouse, parents, siblings or children) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.
- b. Persons are eligible to win prize(s) valued at \$600 or more only once every six (6) months.
- c. The winner(s) may be required to present valid government-issued photo identification and must provide winner's complete address, date of birth and phone number to claim a prize(s).

- d. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

### 3. PRIZES

- a. Up to twenty (20) Qualifying Prizes will be awarded in the Promotion. Each Qualifying Prize is one (1) \$25 Disney Gift Cards, valid at any Disney park, cruise, or online at DisneyStore.com. The Approximate Retail Value (“ARV”) of each Qualifying Prize is \$25.00. The gift cards will be subject to the terms and conditions as set forth by the issuer of the gift cards. Gift cards are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will gift cards be replaced if lost or stolen.
- b. Up to one (1) Grand Prize will be awarded. The Grand Prize includes the following:
  - i. Four (4) round-trip coach airfares on Alaska Airlines (valid for winner and three (3) guests) between Seattle International Airport on pre-determined flights on July 23, 2017 and returning on pre-determined flights on July 25, 2017 and a Southern California area airport (to be selected at Disney’s sole discretion).
  - ii. A voucher for roundtrip ground transportation between the Southern California area airport and a hotel at the Disneyland Resort in Anaheim, CA.
  - iii. One (1) hotel room (maximum of four (4) persons per room) at a Disneyland Resort hotel (to be selected at Disney’s sole discretion) for two (2) nights in Anaheim, CA.
  - iv. Four (4) 3-Day Disneyland Resort Park Hopper Tickets (valid for winner and three (3) guests).
  - v. ARV of the Grand Prize is \$3,248.00 plus tax. Grand Prize travel must occur on pre-determined flights on July 23 and July 25, 2017. The winner(s) and his/their guest must travel together on the same itinerary. If winner cannot travel on July 23-25, 2017, winner must forfeit trip and another winner will be selected. Winner will not receive compensation for any prize elements that the winner is unable to use due to cancellation of the Flight or otherwise and such unused portion of the prize will be forfeited. Any difference between stated value and actual value will not be awarded. Certain restrictions shall apply to the Grand Prize, which restrictions shall be determined by Disney in its sole itinerary. Saturday stay may be required. Travel arrangements must be made through the Station or its designee. Prize(s) is subject to availability. discretion. The winner(s) and guest(s) must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. Airline regulations apply. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. The winner(s) and guest(s) must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. The Grand Prize (and all elements thereof) are not redeemable for cash and are non-transferable except in Disney's sole discretion. The Grand Prize may not be sold or transferred to any other person or third party. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Promotion Entities, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. Disney Destinations LLC and Alaska Airlines are not responsible if flight is delayed, postponed or canceled for any reason. The Station and/or venue, in their sole discretion, reserve the right to deny entry to or to remove the winner and/or guest if either engages in disruptive behavior or in a manner with intent to annoy, abuse, threaten or harass any other person at any Grand Prize-related event. Prize fulfillment is subject to certain restrictions and is subject to hotel availability at the Disneyland Resort. Advanced reservations required. The Grand Prize is for the winning person and three (3) guests of the winner's choosing. Travelers under the age of eighteen (18) must be accompanied by a parent/legal guardian who must be eighteen (18) years of age. Grand Prize components and tickets may not be sold, redeemed for cash, traded, transferred, or rescheduled to dates other than as set forth above. Disney, its parent, subsidiary, related and affiliated companies and their respective officers, directors employees and agents shall be released and discharged from any and all legal claims, losses, injuries, demands, damages, actions, and/or causes of actions which arise out of and/or in any way related to the prize, the recipient, use and/or enjoyment of the prize and/or the Promotion.

The Qualifying Prize winner(s) will forfeit any prize(s) or prize certificate(s) not claimed within thirty (30) days of winning. The Grand Prize winner will forfeit any prize(s) or prize certificate(s) not claimed by 5:30pm PT on July 12, 2017. In the event that a prize or prize certificate is mailed or shipped to the winner(s), it will be with the prior written consent of the winner(s) and therefore, winner(s) assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize(s) or prize certificate(s).

- d. Prize(s) is not transferable, and no substitution, assignment or cash equivalent of prize(s) is permitted, except by the Station (solely at its discretion), which reserves the right to substitute a prize or prize portion with another prize or prize portion of greater or equal value. The prize(s) are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Promotion Entities are not responsible for winners' limitations that prevent acceptance or use of prize(s). Entrants acknowledge that the Promotion Entities have not made, and are not in any manner responsible or liable for, any warranties, representations or guarantees, and hereby disclaim any and all warranties, expressed or implied, whether by contract or law, concerning any prize, including without limitation, implied warranties of quality, merchantability, mechanical condition or fitness for a particular purpose. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Promotion are final.
- b. Up to twenty (20) Qualifying Prize winners will be selected on Wednesday, July 5, 2017 at approximately 12:00pm PT in a Station-conducted random drawing from among all eligible online and text entries received.
- c. Non-selected entries will not automatically rollover or be eligible for any subsequent random drawings during the Promotion. Potential Qualifying Prize winner(s) will be notified of winning by telephone immediately following each random drawing. If a potential Qualifying Prize winner does not answer their initial notification call or does not return the Station's call within ten (10) minutes of the initial notification call (as determined by the Station in their sole discretion), the Qualifying Prize will be forfeited and an alternate winner may be selected in a random drawing of all remaining combined eligible online and text entries received (time permitting) at Station's sole discretion. This will continue until ten potential Qualifying Prize winners answer the initial notification call or returns the Station's call within ten (10) minutes of the initial notification call.
- d. Immediately after all Qualifiers Prizes have been awarded from the Station-conducted random drawing at approximately 8:00am PT on Friday, July 7, 2017, up to one (1) Grand Prize winner will be selected in a Station-conducted random drawing from among all Qualifying Prize winners selected. The potential Grand Prize winner will be notified of winning by telephone promptly following the random drawing. If the potential Grand Prize winner does not answer their initial notification, the Grand Prize will be forfeited and an alternate Grand Prize winner may be selected in a random drawing of all remaining Qualifying Prize winners at Station's sole discretion. This will continue until one (1) potential Grand Prize winner answers the initial notification call.

- e. In the event that all twenty (20) Qualifying Prize winners have been contacted and none answered their initial notification call then no Grand Prize will be awarded.
- f. Odds of winning a Qualifying Prize depend upon the number of text and online entries received. Odds of a Qualifying Prize winner winning the Grand Prize are 1:20.
- g. Entrants must listen to the Station to acquire the announced Keyword for entry via text message or online but need not be present to enter or win.
- h. The Qualifying Prize and Grand Prize will be awarded only upon confirmation of eligibility and completion of all requisite releases. Qualifying Prize winner(s) must execute and return any required affidavit of eligibility and/or liability/publicity release within thirty (30) days of being notified the prize is available or the Qualifying Prize will be forfeited and an alternate winner will not be selected. The Grand Prize winner must execute and return any required affidavit of eligibility and/or liability/publicity release by 5:30pm PT on Wednesday, July 12, 2017 or Prize will be forfeited and an alternate Qualifying Prize winner may be selected (time permitting) in a random drawing from the remaining eligible Qualifying Prize winners. If a winner has not reached the age of majority in his/her state of residence, the prize(s) will be awarded in the name of his/her parent or legal guardian. If a potential winner(s) cannot be contacted, fails to sign and return the required fully-executed affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize(s).

## 5. CONDITIONS

Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize(s). Such winnings of \$600 or more will be reported to the IRS.
- b. Participation in the Promotion and/or acceptance of prize(s) constitutes entrant's and/or winner's (and guest's, if applicable) permission for the Station or its designees to interview the winner(s) (or guest(s), if applicable), to photograph, film and record each winner (or guest, if applicable), and to use in commerce and in any media, now or hereafter known, throughout the world, in perpetuity, his/her name, prize(s) won, hometown (city and state), biographic information, likeness,

photograph, voice, audio or video recording and/or any statements made by him/her regarding the Station, the Promotion and/or its sponsor(s) for purposes of trade, publicity or promotion without notice or additional compensation, notification or permission, in perpetuity, except where prohibited by law. Each winner (and guest, if applicable) agrees to sign a publicity release confirming such consent prior to acceptance of the prize, except where prohibited by law.

- c. - d. If for any reason this Promotion cannot be executed as planned, including but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Released Parties that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend and/or modify the Promotion. If the Promotion is terminated before the original end date, the Station reserves the right, in its sole discretion to, to modify the procedure for selecting winner(s), unless the nature of the event giving rise to such termination renders it impossible to select winner(s).
- e. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize(s); (ii) incorrect or inaccurate entry information, human error, failure or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone service outages, delays, busy signals, poor signals or signal interference, accidental disconnection or equipment malfunctions or any other technological problems or failures of any kind; or (vi) any cancellations, delays, diversions, substitutions or omissions whatsoever by any transportation providers or any other persons or entities providing any services to winner(s) (and guest(s), if applicable) including any results thereof such as changes in services or location necessitated by same. Further, the Released Parties are not responsible if any part of a Promotion prize cannot be

awarded due to acts of God, acts of war, natural disasters, weather, acts of terrorism or other factors beyond the Released Parties' control.

- f. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins or any other methods may void that entrant's entries and that entrant may be disqualified. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address or (ii) is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Promotion. Failure to comply with the rules of the Promotion may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered Promotions and seek damages to the fullest extent permitted by law.
- g. The Station reserves the right to make changes to the rules of the Promotion, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Promotion Entities, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel, terminate, suspend or modify the Promotion and shall not be required to award a substitute prize(s).
- h. Except where prohibited, by entering the Promotion, each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize(s) awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in New York, NY; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall such costs include attorneys' fees; and (3) no punitive, incidental, special, consequential or other damages, including, without limitation, lost profits may be awarded (collectively, "Special Damages"), and (4) entrant hereby waives all rights to claim Special Damages and all rights to have any damages awarded multiplied

or increased. New York law governs the interpretation and construction of these Official Rules and all aspects related thereto.
